**Subject: Amendment in Export Policy of De-Oiled Rice Bran -reg**

S.O. (E). — In exercise of powers conferred by Section 3 read with section 5 of the Foreign Trade (Development & Regulation) Act, 1992, read with Para 1.02 and 2.01 of the Foreign Trade Policy 2023, as amended from time to time, the Central Government hereby, in amendment of the earlier Notification No. 76/2023 dt. 15th March 2024, makes the following changes in Export Policy conditions under Chapter 23 of Schedule-II (Export Policy):

<b>2306 90 29</b> - Other --- Oil-cake and oil-cake meal, solvent extracted (defatted) variety: ---- Of other seeds	Free	Export of De-oiled Rice Bran is 'Prohibited' till 31 <sup>st</sup> January 2025.
<b>2306 90 90</b> - Other --- Other	Free	Export of De-oiled Rice Bran is 'Prohibited' till 31 <sup>st</sup> January 2025.

**Effect of the Notification:** Export of De-Oiled Rice Bran is 'Prohibited' up to 31<sup>st</sup> January 2025.
